

CALL FOR THE SELECTION OF TEMPORARY RESEARCH PERSONNEL TO CARRY OUT SPECIFIC SCIENTIFIC AND TECHNICAL RESEARCH PROJECTS.

The COIE is requested to make a public call for the selection of temporary research personnel to carry out specific scientific and technical research projects to be funded, in accordance with the following:

RULES

FIRST.- PURPOSE OF THE CALL

The purpose of the call is the selection of research personnel (No. of post offered 1), to carry out the Project 'TRABAJOS DE INVESTIGACION EN LA CUEVA DEL MIRON - 2023', whose principal investigator is Mr / Mrs. IGOR GUTIERREZ ZUGASTI of the department / institute Instituto Intern. de Inv. Prehistóricas de Cantabria and its funding will be covered by the budget application 05.54.00.H093.541A.6 corresponding to the following modality Consejería de Universidades, Igualdad, Cultura y Deporte Gobierno de Cantabria

SECOND.- FUNCTIONS AND TASKS OF THE POSITION

FUNCTIONS:

Treatment of the photogrammetric information of habitation floors of the campaigns of excavation in Cueva del Mirón for recovery of spatial data, data processing of environmental conditions of the site through GIS and preparation of informative contents.

TASKS:

Management of total station in archaeological excavations 2023 and treatment of recovered data.

Photogrammetric reconstitution, generation of orthoimages and digital models and coordinates recovery of excavated materials in the cave for inclusion in the inventory deposit overview.

Integration of the data in the general topography of the cave.

Treatment of information on environmental data of the territory of the site and creation of cartography using GIS.

Update of databases for integration of the previous information.

Preparation of reports and content for complementary teaching and informative material.

Only candidates who have exceeded 50 points during the evaluation process may be proposed for the position.

THIRD.- POSITION CATEGORY AND QUALIFICATION REQUIRED

RESEARCHER - UNIVERSITY DEGREE responsibility II

Geography (undergraduate, master's and bachelor's degrees)

FOURTH.- REQUIREMENTS FOR APPLICANTS

Applicants must meet the following requirements:

1) Have Spanish nationality or have the nationality of a member state of the European Union or be from any of the states in which, by virtue of international treaties established by the E.U. and ratified by Spain, the free movement of workers is applicable. Likewise, applicants with a nationality other than that mentioned above may submit their application, provided they can prove that they are in possession of a work and residence permit at the time the contract is formalized.

2) To be in possession of the qualification required in this call. Documents issued abroad that are to be used in this procedure must be legalized in accordance with the current regulations (Management circular number 134).

3) Persons who have had an employment contract for access to the Spanish science, technology and innovation system, governed by article 22 of Law 14/2011 of 1 June on Science, Technology and Innovation of a duration equal to or greater than 5 years, taking into account the duration of this job offer, may not participate in the selection process.

4) .Demonstrate experience in environmental data processing and cartography using GIS.

5) .Demonstrate experience in designing reports and supplementary didactic material related to the subject of the contract

FIFTH.- APPLICATIONS

SIXTH.- DURATION

In order to proceed with the formalisation of the contract once the selection process has been passed, the selected person must meet the requirements established in Article 15.5 of Royal Legislative Decree 2/2015, of 23 October, approving the revised text of the Workers' Statute Law (amended by Royal Decree-Law 32/2021, of 28 December).

This contract for circumstances of production will have a duration of 6 months (maximum of 6 months) and is signed in accordance with the provisions of section 1 and 2 of article 15 of Royal Legislative Decree 2/2015, which approves the revised text of the Workers' Statute Law.

SEVENTH.- REMUNERATION

The employee's salary will be 9.254,52 (6 months) (gross salary including the proportional part of the extraordinary payments during the contract).

EIGHTH.- MERITS ASSESSMENT
